For Guests Staying in Hokkaido an Accommodation Tax Will Be Introduced from April 1, 2026

観光の付加価値の向上、観光に係るサービス及び旅行者を受け入れるための体制の充実強化、災害等の危機に対応する取組等、観光振興を図る施策に活用します。

Proceeds from the accommodation tax will be used to enhance the tourist experience, improve services related to tourism, strengthen systems for welcoming travelers, and fund disaster response and other emergency response measures, thereby promoting tourism.
